El Segundo business. Opportunity arose for me in 1997 and I began working here for TG Construction and stayed involved with the Chamber. Over the years I have really gained an appreciation for our diverse business community I am proud to be involved with this Chamber.

So why did I want our Installation Dinner to be held on Historic Richmond Street? That is where El Segundo Business all began! 100 years ago The Standard Oil Refinery was born- back when crude oil prices were a staggering 35 cents a barrel! Their 600 employees processed 15,000 barrels a day compared to today's 250,000. With the refinery, came businesses to serve those working and living in this little industrial sea-side town. Right on this very 100 block of Richmond Street in 1911, Martin & Ellis became the first store in town. They sold everything from cigars to tools. Also on this street was the first barber shop in town operated by Floyd Carr Sr., the father of our very own former mayor Floyd Carr who still serves our community. Richmond St. also was home to a Piggly-Wiggly, Douglas Mortuary (Southeast corner of Richmond and Franklin), City Hall (across the street at the Northeast corner), and of course the State Theater which is now our beloved Old Town Music Hall. A song was written in 1914 called "El Segundo by The Sea" to help attract land purchasers to our city. A flyer issued with the song stated "Other big industries are arranging to come. El Segundo will be a great hive of industry, a happy and prosperous home city, with constantly increasing realty values". Well, those folks really nailed it. Look at what we've grown to become!

As history progressed, so did business. In 1941 American Motors built the Nash automobile plant. In 1955 Hughes bought that building for \$3M, and now Boeing builds satellites there. Jack Northrop was also building airplanes in what is still the world's longest wooden building- a half mile long that now is where Northrop Grumman builds fuselage sections for the F/A-18 Hornet among other things.

In 1960 The Aerospace Corporation was born along with the L. A. Air Force Base bringing opportunity to so many other feeder businesses and driving such huge projects as the Hubble Space Telescope and the World's GPS system. Since then we've seen so many business successes- Continental Park, Jim & Jacks Automotive, Raytheon, Xerox, Pacific Corporate Towers and all the firms there, Mattel, International Rectifier. And recent additions such as British Telecom, Karl Storz, Tesco (the parent of Fresh & Easy Markets), Rhythm & Hues, all of our wonderful hotels, restaurants, and merchants; and

Downtown Business of the Year Old Town Music Hall

The Downtown Business of the Year Award was presented to a hidden gem that graces Downtown El Segundo! One of the last vestiges of a bygone era of entertainment, the Old Town Music hall opened Downtown in 1968 at the site of the 1922 El Segundo State Theater. The Old Town Music Hall is a concept that started in 1958 by Bill Coffman and Bill Field with the purchase of the Mightly Wurlitzer from the Fox West Coast Theater in Long Beach, California. Renowned as the home of the Mighty Wurlitzer pipe organ, this one-of-a kind venue features showings of classic and silent films from a variety of genres, live organ concerts, ragtime and jazz piano concerts and more. Business of the Year Award Chevron El Segundo Refinery

The 2010 Business of the Year Award was presented to Chevron El Segundo Refinery. This is not just for the contributions Chevron has made to the community in the last 12 months but for the last 1200 months as they celebrate their 100th Anniversary in El Segundo. The history of Standard Oil and Chevron's involvement in the community runs deep.

As mentioned in the El Segundo 75 years Anniversary Book, in the early days of El Segundo the same leaders who ran the refinery most likely ran the Chamber of Commerce. There are also several parts

highlighting Standard Oils involvement in those early days. The book mentions the opening of the first library in El Segundo located in the El Segundo Hotel and says "Standard Oil Company paid the first year's rent for the library space". Another story tells of Harriett Lawler who was employed in 1911 as secretary to Standard Oil's first General Manager and how she founded the Childrens Hospital Auxiliary around 1920.

The company has always embraced community spirit allowing employees to become deeply involved in the volunteer work that makes up our community and they continue to do so today with programs such as the \$1 million dollar "Energy for Learning" grant to support science, technology, engineering and math educational programs at 15 South Bay schools, support of local service organizations through projects such as Rotary's Movie in the Park, Tree Musketeers Arbor Day plantings and more. A recent donation of land by Chevron is enabling a new lifeguard station for El Segundo beach. And every year you can see hundreds of Chevron employees and their families making their way down Main Street in the Holiday Parade enjoying this community they love. We thank Chevron for "starting it all" in this little patch of sand dunes in 1911 and for all they have given to our community over the past 100 years.

2010 Vote Records: Holding Elected Officials Accountable

The 2010 Vote Record: The El Segundo Chamber of Commerce in conjunction with the SBACC tracked votes on 23 Potential Laws for Senator Alan Lowenthal, Senator Roderick D. Wright, Assembly Member Steven C. Bradford, Assembly Member Warren T. Furutani, Assembly Member Ted Lieu, Assembly Member Bonnie Lowenthal, and Governor Arnold Schwarzenegger.

In 2010, The El Segundo Chamber of Commerce in conjunction with the SBACC tracked 23 potential laws (bills) that impact over 53,000 businesses throughout the South Bay region. Regional legislators received letters communicating the positions on all 23 bills. The Chamber, working with its regional advocacy coalition the South Bay Association of Chambers of Commerce (SBACC) lobbied during the 2010 legislative session for our legislators to OPPOSE 12 bills and SUPPORT 11 bills.

"This was a difficult year for our business community. We need to continue to work with our legislators in order to help our business community rebound by creating jobs and positive economic growth," stated Marsha Hansen, Chamber CEO/Executive Director. "These vote records demonstrate how our elected officials voted with our business community and we can continue to hold them accountable. This year needs to be the year where our elected officials side with business in order to get our region back on track."

The official positions on each of the 23 bills have been available online at www.SBACC.com including summaries and explanations of why each bill was opposed and supported.

To reach the "percentage FOR pro-jobs legislation," the tallied the number of times our legislators voted for the position and divided that total by the total number of potential new laws in which each legislator voted. A potential new law is not figured into the vote record percentage if a legislator, for whatever reason, did not vote or if the potential new laws died before the legislator had an opportunity to vote.


