Recently, I had the pleasure of attending the South Bay Association of Chambers of Commerce Installation luncheon where Marcella Low was installed as the 2009 President. Marcella is with The Gas Company and also co-chairs our Government Affairs Committee.

State Controller, John Chaing who was the keynote speaker for the event not only spoke about the economic situation our state is facing but also touched on a program that I think most would find interesting. In fact, my friends and colleagues have not only found it interesting. They have also found approximately \$13,000.00! Simply by logging on to the State

Controller's website and clicking on the Unclaimed Property Program you too might find some "extra" funds waiting for you.

Created in 1959, and in place in every state in the country, the Unclaimed Property Law is intended to safeguard abandoned or forgotten property – such as bank accounts, utility deposits or stock certificates – from being lost during mergers or bankruptcies, drawn down by service or storage fees, or simply used by private interests for personal gain, either through an unwillingness to find the owner or greed.

For the past 20 years, State laws prevented the California Controller's Office from contacting more than 80% of owners whose property was sent to the State because the owner could not be found and there was no activity on the account for at least three years.

Upon being sworn into office in January 2007, Controller John Chiang immediately made reforming the Unclaimed Property Program one of his top priorities. He successfully sponsored reform legislation that lifted those legal restrictions that prevented him from notifying individuals believed to be the owners of unclaimed property, and now can notify all owners of property already received by or about to be sent to the State. In the first year after the enactment of his reform bill in August 2007, the Controller sent 2.5 million notices to property owners - more than double the 1.2 million notices sent out in the previous decade.

Controller Chiang continues to make improvements to the program to help unite owners with their lost property. He maintains a searchable Web site at www.ClaimIt.ca.gov where individuals and businesses can search for property owed to them, friends or family in English, Spanish, Chinese and Tagalog.

The Controller's Unclaimed Property web site allows consumers to not only search for properties that are held by the State, but also properties that are scheduled to be sent to the State by a business that has deemed the account abandoned. The business' contact information is included on the database so that property owners can contact the company and either reactivate their account, or claim the property from the business directly.

This year, the Controller is sponsoring legislation (AB 1291) to prohibit financial institutions from sending to the State the contents of safe deposit boxes if the reported owner has an active checking or savings account at that institution. To give property owners a longer time to claim their property, the bill also seeks to extend from the current three years to five years the time a safe deposit box must be considered abandoned before it is sent to the State for safekeeping. Under current law, contents of safe deposit boxes with no commercial value must be destroyed 18 months after they are sent to the State. Recognizing that old letters, photos or other property may be of huge sentimental value to the owners, the Controller's bill also would allow the State to keep those items for seven years to provide the owners with more time to claim them.

The Aerospace Corporation New Corporate Headquarters Grand Opening

More than 50 dignitaries and hundreds of Aerospace employees gathered for the official Grand Opening celebration of their new Corporate Headquarters (Building A9) on Tuesday, April 21.

Distinguished guests from the Space and Missile Systems Center, the Aerospace board of trustees, elected officials, local business leaders, and Aerospace employees and senior management joined the celebration.

Renee Simon, project leader, Enterprise Information Services, served as the master of ceremonies for the event and introduced Dr. Wanda Austin, president and chief executive officer. "This is a very exciting day for all of us at Aerospace and the Space and Missile Systems Center," said Austin. "The original plan for A9 began in 2003. It was put on hold due to BRAC [Base Realignment and Closure] and was reinvigorated in 2007, and now it has finally come to fruition," she said.

Austin explained that although the other headquarters (Building A1) was at the cutting edge of architectural style, construction techniques, and engineering practices when it opened in 1964, as the years progressed, it did not meet updated earthquake standards. Research into the cost to retrofit the building culminated in the decision to construct a new economically efficient building for about the same price as the cost of the retrofit. As part of the master plan, Aerospace agreed with the city to demolish A1 for much needed parking space. That demolition will take place in fiscal 2010, according to Austin.

The STARS (Spacelift Telemetry Acquisition and Reporting System) Lab includes 69 consoles with a seating capacity of 78, 15-foot by 26.8-foot high-definition screen and an upstairs viewing area and theater seating for 26 people. The new building has 4 floors however has 50% more sq. footage of space than

the prior building with 6 floors. There are 25 conference rooms in the new headquarters building as well as the Titan IV Meeting Center which has a capacity of 500 people.

Lt. Gen. John T. "Tom" Sheridan, commander, Space and Missile Systems Center, took the stage after Austin and stated that the greatest asset of Aerospace is its people and the technical expertise each person brings to the corporation and to the entire national security space mission.

"Since 1960, the people at Aerospace

have been an invaluable asset to the Space and Missile Systems Center in helping us achieve our mission to design, deliver, launch, and sustain America's military space capability. You provide the technical backbone to help us fly, fight, and win," Sheridan said.

The event ended when the dignitaries were taken on a tour to the new Meeting Center that holds 500 employees, and to view location where a pedestrian bridge that crosses El Segundo Boulevard, and will permanently connect SMC to Aerospace will be installed.
